## **MY Response– ICIBI call for evidence, an inspection into Home Office’s use of age assessments**

**Summary:** Migration Yorkshire recently submitted evidence to the Department for Levelling Up Housing and Communities Migration Yorkshire recently submitted evidence to the Independent Chief Inspector of Borders and Immigration (ICIBI) on their inspection into the Home Office’s use of age assessments. Our response is informed by the work of our UASC service which undertakes strategic coordination work supporting Local Authorities children’s services teams, Home Office and the Department for Education with the National Transfer Scheme and ensuring there is high quality support for unaccompanied asylum-seeking children across the region. The UASC service is led and managed by qualified social workers who have previously worked in voluntary and statutory settings with UAS children, including directly undertaking age assessments and acting as an appropriate adult during age assessments.
