## Refugee integration news

- The Office for National Statistics (ONS) released [Census 2021 data for ethnicity, nationality, language and religion](#) and have also produced an [interactive map to explore data at different geographic levels](#). (Source: ONS)
- A YouGov poll has found that while [most people think there is too much immigration many acknowledge a need to bring in workers from abroad](#), leading to [a call for British politicians to catch up with British public on the benefits of immigration](#). (Source: The Times; Guardian)
- A report from the Refugee Studies Centre in Oxford calls for [a new national refugee policy for Britain](#), advising that the UK needs a whole-of-government approach to deliver effective refugee integration, and should allow the right to work for asylum seekers after six months from arrival. - [The Commission on the Integration of Refugees published its first report](#) 'A Broken System? Asylum Reform Initiatives, 1997-2022' examining how far integration has been a priority in asylum legislation and analyses successes and failures in previous efforts to reform the asylum system. - [An increasingly militarised approach to immigration and 'border spectacularisation' over the past 12 years is analysed in this article](#). The author argues harsh policies need public consensus, so by drawing attention to immigration in this way, the public is encouraged to associate 'migration' with 'illegal'.
